### ADDENDUM NO. 1

## PURCHASE OF LED VIDEO DISPLAY BOARDS

### FILE NO. 113-24

This addendum is being issued to provide answers to questions received from potential bidders.

Q. #1. Just a quick clarification: Is the affidavit mentioned on page 36 in reference to Pages 20-22? If not, please advise.

Answer: The affidavit referenced in the bid package are not the same. The bid affidavit provided on pages 20-22 is a requirement of all bidders submitting a bid to the City of Cleveland as identified in the Instructions to Bidders, under A-3. The Affidavit of Compliance — Prevailing Wages, is to be completed by the officer or agent of the contractor or subcontractor supervising payments for their employees.

Q. #2 thru 4. What is the Depth of Cabinet? What is the size of the Cabinet? Please provide the Existing Sign Image to be removed (see attachment). Is this subject to prevailing wages?

Answers to Q. #1 and #2: The sign is a two-sided unit  $5' - 7'' \times 21' - 2'' \times 10''$ . Answer to Q. #3: A copy of the existing sign image is included with this addendum. Answer to Q. #4: Yes, this bid is subject to prevailing wages.

Q. #5. I just want to clarify that this bid request is to only remove and replace the existing LED boards, correct? The logo sign will be untouched and not replaced as well as the entire structure. Can you please confirm?

Answer: Correct. The logo sign and structure are to remain intact.

All other documents shall remain in full force and effect. Failure to comply may result in your bid being considered non-responsive. Thank you.
