Answers to questions received by the last day for questions:

1. Please advise if program modifications for the plant wide SCADA systems are required after the new control panels are installed or if that is to be completed under a separate contract.

Answer: Section 40 61 13, paragraph 1.1.D indicates that a Control System Integrator shall update the PCCS, as part of this contract.

2. Sheet E-7 indicates to install a fiberoptic patch cord to be installed in the Potassium Permanganate control panel. Please provide a specification for the cable and connectors to be used.

Answer: DPU will provide a new network switch and SM fiberoptic patch cable which they will install in the POTP panel. Contractor is responsible for running the CAT-6 cables down to the new Traveling Screen control panels, and for the terminating and testing of the Ethernet cables and connectors.

3. It was mentioned that a traveling screen frame was in need of repair at Baldwin. Please advise on what the repairs will need to be.

Answer: The head frame, stored at Fairmount, is not square and will need to be realigned. The head frame shall be shipped to the manufacturer along with the traveling screen which is to be factory re-built. The manufacturer will then refurbish and straighten the head frame.
