ADDENDUM NO. 6

The bid due date is July 18, 2024 and bids must be date stamped no later than 11:59 a.m. that day.

Changes to the Specifications:

- 1. Bid Overview Add the following to page 2 The Work of Project:
 - "k. Structural repairs to the roof of the Green Road Pump Station Gate House Building."
- 2. Section 01 01 00 Summary of Work 1.04 A. 1. Add the following:
 - "k. Structural repairs to the roof of the Green Road Pump Station Gate House Building."
- 3. Section 01 21 00 Allowances Part 2 Add the following:
 - "2.03 Schedule of Allowances 1. Allowance No. 1 \$50,000.00 Structural repairs to the roof of the Green Road Pump Station Gate House Building."

The total of the above allowance, \$50,000.00, should be included in bidder's total for Item No. 1 of the Bid – Schedule of Items.

Change to the Bid - Schedule of Items page:

1. Replace the original Bid – Schedule of Items page with the attached Addendum No. 6 one.

Answers to questions received by the last day for questions:

- 1. Addendum #5 / question #5 states that the floor loading maximum is 200 psf. Should this be 200 pounds/square inch?
 - Answer: No, the posted loading is 200 PSF.
- 2. Does any of the copper pipe for the water instrumentation get replaced?
 - Answer: No, copper pipe to remain as existing.
- 3. Roof Specification 07 22 16 calls for hot mopping asphalt which has fallen out of favor due to the fire risks. Would an alternate of 60 TPO and tapered insulation be approved?
 - Answer: Bid as specified. Alternates may be considered during construction.
