# AUTHORIZING ORDINANCE AS PUBLISHED IN THE CITY RECORD

Ordinance No. 1054-2024 By Council Members: Kazy and Griffin (by departmental request)

An emergency ordinance authorizing the purchase by one or more purchase by one or more requirement contracts of labor and materials necessary to test, inspect, maintain, and repair bucket and derrick trucks, for the Division of Cleveland Public Power, Department of Public Utilities, for a period of two years.

WHEREAS, this ordinance constitutes an emergency measure providing for the usual daily operation of a municipal department; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CLEVELAND:

Section 1. That the Director of Public Utilities is authorized to make one or more written requirement contracts under the Charter and the Codified Ordinances of Cleveland, Ohio, 1976, for the requirements for the period of two years of the items of labor and materials necessary to test, inspect, maintain, and repair bucket and derrick trucks, in the approximate amount as purchased during the preceding term, to be purchased by the Commissioner of Commissioner of Purchases and Supplies on a unit basis for the Division of Cleveland Public Power, Department of Public Utilities. Bids shall be taken in a manner that permits an award to be made for all items as a single contract, or by separate contract for each or any combination of the items as the Board of Control determines. Alternate bids for a period less than the specified term may be taken if desired by the Commissioner of Purchases and Supplies until provision is made for the requirements for the entire term.

Section 2. That the costs of the contract or contracts shall be charged against the proper appropriation accounts and the

Director of Finance shall certify the amount of any purchase under the contract, each of which purchases shall be made on order of the Commissioner of Purchases and Supplies by a delivery order issued against the contract or contracts and certified by the Director of Finance. (RQN 2004, RL 2024-22)

Section 3. That under Section 108(b) of the Charter, the purchases and/or services authorized by this ordinance may be made through cooperative arrangements with other governmental agencies. The Director of Public Utilities may sign all documents that are necessary to make the purchases and/or obtain such services and may enter into one or more contracts with the vendors and/or consultants selected through that cooperative process.

Section 4. That this ordinance is declared to be an emergency measure and, provided it receives the affirmative vote of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by Law.

Passed November 4, 2024. Effective November 6, 2024.



# WAGE THEFT AND PAYROLL FRAUD DISCLOSURE

#### SUMMARY:

Bidders on certain City contracts, recipients of Assistance, and any of their prospective subcontractors must disclose any wage theft or payroll fraud violations over the last three years. Unless they receive a waiver from the City's Fair Wage Employment Board, violators are placed on the City's Adverse Determination List, which prevents them from entering into new contracts with or receiving Assistance from the City. This disclosure requirement and the waiver process are set forth in Chapter 190 of the Codified Ordinances of Cleveland, Ohio, 1976 ("Chapter 190").

# **INSTRUCTIONS:**

Pursuant to Chapter 190, the information requested on this document must be provided by any person or entity bidding on or making a proposal for a Construction or Improvement Contract or a Service Contract, or applying for Assistance, and any of their prospective subcontractors.

Any person or entity that is deemed to have made a false statement shall be declared to have acted in default of its contract and shall be subject to the remedies for default contained in its contract.

#### **DEFINITIONS:**

"Adverse Determination" means a final action or adjudication that the person or entity in question has committed Wage Theft or Payroll Fraud and is further defined in Chapter 190.

"Assistance" means any form of City financial assistance, except for financial assistance provided for the development, rehabilitation or other means of providing residential housing. Assistance includes but is not limited to: grants; economic development loans; tax credits, incentives and abatements; subsidies; and bonds. Assistance does not include financial assistance which is received from another government or other entity with the City acting only as a conduit or fiscal agent for the funds, where the City exercises no control over the identity of any recipient or of the terms of the contract. Community Development Block Grant Funds are not considered conduit funds and, to the extent they otherwise qualify, are included as Assistance.

"Construction or Improvement Contract" means any contract entered into pursuant to Chapter 167 or Chapter 185 of the Codified Ordinances.

"Payroll Fraud" means concealing an entity's true payroll tax liability or other financial liability to a government agency from government licensing, regulatory or taxing agencies through misclassification of employees, failure to report or underreported payment of wages, or executing a cash transaction while failing to maintain proper records of reporting and withholding.



"Service Contract" means any contract or subcontract between a person, business or corporation and the City of Cleveland that primarily involves the furnishing of services to the City (as opposed to the purchase of goods or other property or the leasing of property), and shall be limited to the following categories of services: food service, janitorial, security services, parking lot attendants, home health care, health care aides, waste management, automotive repair services, landscaping, towing contracts, building and maintenance services, carpentry, clerical services, urban forestry, housekeeping, street maintenance and repair, and sidewalk maintenance and repair. This includes services performed on City-owned premises including the following City-owned locations: airports, parking lots, municipal parks, recreational facilities, and City-owned buildings. Contracts that are primarily for the purchase of goods or other property are not considered Service Contracts.

"Wage Theft" means a violation of the Ohio Prompt Pay Statute, RC 4113.15; the Ohio Minimum Fair Wage Standards Act, RC Chapter 4111; Oh. Const. Art. II, Sec. 34a; RC Chapters 4109 or 4115; RC 4113.17, 4113.18, 4113.52 or 4113.61; or a violation of any substantially equivalent federal or state law; as any of these laws may be amended or superseded.

#### INSTRUCTIONS TO BIDDERS

#### A-1 INVITATION TO BID

Sealed bids endorsed as designated in the "Title of Bid" section of the bid sheet(s) will be received at the Office of the Commissioner of Purchases and Supplies, Room 128, Cleveland City Hall, Cleveland, Ohio 44114, until 12:00 o'clock noon, official time, on the date indicated in the "Bid Opening" section of Page 1 of the bid page(s) and thereafter will be publicly opened and read in Room 128.

# A-2 FORM OF BID (BID FORM)

- a. Every bid must be made upon the blank form of bid attached hereto.
- b. Each bid must be clearly signed with the full name and address of every person, firm or corporation interested in such bid, followed by the date of such signing, in the space provided at the bottom of the bid form. If more than one person, firm or corporation has an interest in such bid, then the full name and address of each person, firm or corporation must be clearly signed on said bid. If the bidder is a partnership, the firm name and address, as well as the name and address of each individual partner must be given. If the bidder is a corporation, the name of the corporation, the name and tille of the officer duly authorize to sign for the corporation, the business address of such officer and the name of the state in which the corporation is incorporated must be given.
- c. The bidder shall insert the amount of the bid bond, certified check or cashier's check in the space provided in the bid form.
- d. The bidder agrees to be bound by his bid from the time the bid is submitted until the earlier of the date stipulated by such bidder or the fourth regular meeting of the Board of Control after the bid submission date unless such time is extended by agreement between the bidder and the Board.

## A-3 BIDDERS AFFIDAVIT

Each bidder shall submit with its bid an affidavit stating that neither it nor its agents, nor any other party for it has paid or agreed to pay, directly or indirectly, any person, firm or corporation any money or valuable consideration for assistance in procuring or attempting to procure the contract herein referred to, and further stating that no such money or reward will be hereafter paid. This affidavit must be on the form which is hereto attached.

## A-4 BID BOND: CERTIFIED OR CASHIER'S CHECK

Each bid shall be accompanied by a bid bond signed by a surety company authorized to do business in Ohio, or by a cashier's check or certified check on a solvent bank, which bond or check shall be in the sum of five percent (5%) of the amount of the bid, except that with bids for purchase contracts not in excess of Flfty Thousand Dollars (\$50,000). Said bond or check shall be given as security that if the bid is accepted a contract will be entered into and the performance of it properly secured.

# A-5 DISPOSITION OF BID BOND, CERTIFIED OR CASHIER'S CHECK

a. When the bid is accepted, the bid bond, certifled or cashier's check will be returned after the contract has been signed and the performance bond, if required, has been submitted to, and approved by, the City.

b. If the successful bidder fails to enter into a contract, the bid bond, certified or cashier's check shall be forfeited and the principal amount of the bid bond shall be paid to the City, or the check shall be surrendered to the City as the agreed amount of liquidated damages.

c. The bid bond, certified or cashier's check of the next lowest and best bidder will be retained until the lowest and best bidder has signed and secured the performance of its contract. If such lowest and best bidder fails to do so, the security of the next lowest and best bidder shall continue to be retained until it properly secures the contract awarded it. If such next lowest and best bidder defaults, the principal amount of its bid bond, or check shall also be forfeited to the City as liquidated damages.

d. When a bid is rejected, the bid bond or check will be released or returned, respectively, to the bidder.

# A-6 EXPLANATIONS WRITTEN OR ORAL

Any bidder finding a discrepancy or omission in the specifications or having any doubt as to their meaning, shall immediately notify the Commissioner of Purchases and Supplies, in writing. The Commissioner will respond by sending written notices or instructions to all bidders. The City will not be responsible for any oral instructions.

# A-7 PRICE BIDS AND DISCOUNTS

a. Unit Prices

In the Schedule of Items the bidder must give the unit price stated in figures of every item bid, in the space so provided.

b. Trade Discounts

When the bidder offers a trade discount, the amount of such discount shall be stated on the Schedule of Items bid.

c. Catalog Pricing

Where the bidder submits its quotation by filling its catalog price list and discount, such documents shall be part of the bid and must be separately signed by the same person and in the same manner as on the bid form.

## A-8 BIDDER'S DESCRIPTION OF ITEMS

Each bidder shall, in its bid, describe completely the goods or services it proposes to furnish in response to and under the terms of the bid.

b. The Commissioner of Purchases and Supplies may require a bidder to furnish additional information and/or specifications concerning items to be purchased under the terms of the bid.

### A-9 MANUFACTURER'S NAME

The use of a manufacturer's or a trade name in the specifications is solely for the purpose of designating a standard of quality and type and for no other purpose.

b. Every bidder shall state in its Schedule of Items bid the manufacturer's and the trade name, if any, of each item they propose to furnish.

#### A-10 SAMPLES

If the commissioner of Purchases and Supplies requests, a bidder shall provide samples of the items it proposes to furnish if awarded a contract pursuant to its bid.

# A-11 TIME OF DELIVERY

Bidder must state in its bid the time, in calendar days, within which it will deliver the item(s) bid unless stated differently in the specifications.

# A-12 PAYMENT DISCOUNT WHEN USED TO DETERMINE LOWEST AND BEST

- a. In determining the lowest and best bid, the City will consider all bids on a basis of the net price to be paid after deduction of the discount specified; except that if the terms of payment specified by the bidder require payment in less than thirty (30) days from the date of the invoice, the discount offered will not be deducted from the price stated in the bid to determine the lowest and best bidder, and the bid will be considered only on the basis of the unit price actually named in the bid. But if, notwithstanding the provisions of this paragraph such bid is determined to be the lowest and best bid, the City reserves the right to accept the terms named in the bid if such terms are to the advantage of the City as a basis for payment of invoices only, but not in any case as a basis for determining the lowest and best bidder.
- b. The City will take a discount of two percent (2%) on payments made within thirty (30) days from receipt of articles, commodities, materials, supplies, equipment or services, unless the bidder indicates otherwise on the space provided on the Schedule of Items bid.

PARAGRAPHS A-13 THROUGH A-15 APPLY ONLY IF THE "REQUIREMENT CONTRACT" BLOCK IS CHECKED ON PAGE 1 OF THE SCHEDULE OF ITEMS AND ON THE BID FORM.

# A-13 REQUIREMENT CONTRACT DEFINED

- a. A requirement contract is a contract under which the contractor has a duty to provide the City's requirements during the contract term for all articles, commodities, supplies, materials, equipment and/or services set forth in the bid and required by the City's authorized users of the items approved for contract.
- A contract awarded under this bid will be termed a requirement contract.

# A-14 PURCHASES UNDER A REQUIREMENT CONTRACT

- a. Under a requirement contract, a contractor shall supply all the City's requirements during the term for the articles, commodities, supplies, materials, services or equipment set forth in the *Invitation to Bid*. See GENERAL CONDITIONS, Section B-24, Duration of Contract.
- b. if the Schedule of Items in the Invitation to Bid is marked "requirement contract," then all quantities stated in the Schedule of Items are the City's good-faith estimates only. The City shall place each order under the

contract, whether singly or cumulatively more or less than the estimated quantities set forth in the *Schedule of Items*, by a Delivery Order against the contract and separately certified.

# A-15 LIMITATION OF PERIOD OF CONTRACT

If the proposed duration of the contract would deprive the City of the best available market price, the bidder may offer an alternate bid as to duration of the contract, setting forth in the bid the longest period of time it can furnish and deliver the proportionate amount of items at the firm price set forth in the bid. No other provision of the Invitation to Bid shall be subject to an alternate bid unless specifically requested.

# A-16 BID DISCOUNTS - APPLICABLE TO BIDS FOR GOODS AND SERVICES PURCHASE CONTRACTS AND PUBLIC IMPROVEMENT CONTRACTS IN EXCESS OF FIFTY THOUSAND DOLLARS (\$50,000).

a. Bid Discounts under Sections 187.03 and 187.05. If the bid of any prime contractor that is a CSB, MBE, FBE or a CSB, MBE or FBE joint venture is no more than five percent (5%) higher than the lowest actual bid for a contract that is not from a CSB, MBE, FBE or a CSB, MBE or FBE joint venture, the contracting department shall apply a Bid Discount of five percent (5%) to the CSB, MBE, FBE or CSB, MBE or FBE joint venture bid for the purpose of establishing a Comparison Bid. The City of Cleveland shall use the following ranking in determining who receives the preference:

- Where the disparity study has determined that a disparity exists, the bid discount shall go to the bidders who are certified by the City as members of the specific MBE/FBE group for which the proven disparity exists. No other bidders shall receive any preference under Sections 187.03 and 187.05 at the prime contractor level.
- 2. Where no disparity has been proven, or when no bids are received from groups for which a proven disparity exists, the bid discount shall go to certified CSB bidders certified by the City as located within the city limits of Cleveland. No other bidders shall receive any preference under Sections 187.03 and 187.05 at the prime contractor level.
- 3. Where no disparity has been proven, or when no bids are received from groups for which a proven disparity exists, and no bids were received from certified CSB firms certified by the City as located within the city limits of Cleveland, the bid discount shall go to Certified CSB bidders certified by the City as located within Cuyahoga County. No other bidders shall receive any preference under Sections 187.03 and 187.05 at the prime contractor level.
- 4. In addition to any bid discounts at the prime contractor level, all prime contractors shall receive a bid discount of 5% of the total dollar amount of all CSB, MBE and/or FBE certified by the City that the prime contractor properly documents as subcontractors in their bid, for the purpose of establishing a Comparison Bid.
- The total Bid Discount awarded to any bidder on a bid pursuant to Sections 187.03 and 187.05 shall not exceed \$50,000.00.

b. Bid Discounts under Section 187A.02(a): Application of Bid Discount - A Contracting Department shall apply a Bid Discount of two percent (2%) to a bid received from a Local Producer (LPE); two percent (2%) to a bid received from a Local Food-Producer (LPE); and two percent (2%) to a bid received from a Local Sustainable Business (SUBE); provided that the maximum total Bid Discount applied under Section 187A.02 (a) shall not exceed four percent (4%). Bid Discounts applied under Section 187A.02 (a) shall be in addition to any Bid Discount applied under Sections 187.03 and 187.05. The maximum amount of any Bid Discounts applied under this Section 187A.02 (a) shall not exceed \$50,000.

# c. Maximum Cumulative Amount of All Bid Discounts:

The maximum cumulative amount of all Bid Discounts that may be applied to the bid under Sections 187.03, 187.05, and 187A.02 shall not exceed \$75,000.00, or nine percent (9%), whichever is lower.

# d. Comparison Bid to Determine Lowest and Best Bidder:

The City shall determine the Comparison Bid by totaling all applicable Bid Discounts under Sections 187.03, 187.05, and 187A.02. The City shall use the Comparison Bid in determining the lowest and best or lowest responsible bidder for the purpose of awarding the contract. If more than one CSB, MBE, FBE, LPE, SUBE or CSB, MBE, FBE LPE, SUBE joint venture prime contractor in the respective category submits a bid that is no more than five percent (5%) higher than the lowest actual bid that is not from a CSB, MBE, FBE, LPE, SUBE or from a CSB, MBE, FBE, LPE, SUBE joint venture, the contracting department shall recommend the CSB, MBE, FBE, LPE, SUBE, or CSB, MBE, FBE, LPE, SUBE joint venture submitting the lowest bid, after the inclusion of all applicable prime and subcontractor discounts, as the lowest and best or lowest responsible bidder.

The City shall use the Comparison Bid amount determined by applying the bid discounts described in <u>Articles A-16A</u>, and <u>A-16B</u>, above for evaluation purposes only; the City shall use the actual bid amount for the purposes of bid approval and contract award.

e. City of Cleveland Certification required: For the purpose of determining a bidder's eligibility for bid discounts, the City shall only consider bidders with valid certificates issued by the City of Cleveland's Office of Equal Opportunity. The certifications must be active on the date and time of the deadline for bid submission. Expired certification holders and pending certifications cannot be considered for calculation of bid discounts. Certifications from other public or private entities cannot be considered.

- 3. Active attendance and participation in all prebid meetings, Notice to Proceed meetings, and progress meetings during the contract;
- Active compliance and cooperation with Project Monitors from OEO and/or the Department; and,
- Timely and accurate submittals of all required forms, including, but not limited to, electronic monitoring forms, employment reports and certified payrolls if applicable.

The final determination of good faith effort shall be made by the Office of Equal Opportunity based upon each bidder's actions as documented in the required forms and as verified by OEO follow up.

- Form 1099-C (canceled debt).
- Form 1099-A (acquisition or abandonment of secured property).

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

**Caution:** If you don't return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See *What is backup withholding*, later.

#### By signing the filled-out form, you:

- 1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued);
  - 2. Certify that you are not subject to backup withholding; or
- Claim exemption from backup withholding if you are a U.S. exempt payee; and

**Definition of a U.S. person.** For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding. Payments made to foreign persons, including certain distributions, allocations of income, or transfers of sales proceeds, may be subject to withholding under chapter 3 or chapter 4 of the Code (sections 1441–1474). Under those rules, if a Form W-9 or other certification of non-foreign status has not been received, a withholding agent, transferee, or partnership (payor) generally applies presumption rules that may require the payor to withhold applicable tax from the recipient, owner, transferor, or partner (payee). See Pub. 515, Withholding of Tax on Nonresident Aliens and Foreign Entities.

The following persons must provide Form W-9 to the payor for purposes of establishing its non-foreign status.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the disregarded entity.
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the grantor trust.
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust and not the beneficiaries of the trust.

See Pub. 515 for more information on providing a Form W-9 or a certification of non-foreign status to avoid withholding.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person (under Regulations section 1.1441–1(b)(2)(iv) or other applicable section for chapter 3 or 4 purposes), do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515). If you are a qualified foreign pension fund under Regulations section 1.897(I)–1(d), or a partnership that is wholly owned by qualified foreign pension funds, that is treated as a non-foreign person for purposes of section 1445 withholding, do not use Form W-9. Instead, use Form W-8EXP (or other certification of non-foreign status).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a saving clause. Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

- 1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
  - 2. The treaty article addressing the income.
- The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
- 4. The type and amount of income that qualifies for the exemption from tax.
- 5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if their stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first Protocol) and is relying on this exception to claim an exemption from tax on their scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident allen or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

#### **Backup Withholding**

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include, but are not limited to, interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third-party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

#### Payments you receive will be subject to backup withholding if:

- 1. You do not furnish your TIN to the requester;
- 2. You do not certify your TIN when required (see the instructions for Part II for details);
  - The IRS tells the requester that you furnished an incorrect TIN;
- 4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only); or
- 5. You do not certify to the requester that you are not subject to backup withholding, as described in item 4 under "By signing the filled-out form" above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See Exempt payee code, later, and the separate Instructions for the Requester of Form W-9 for more information.

#### What Is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all U.S. account holders that are specified U.S. persons. Certain payees are exempt from FATCA reporting. See Exemption from FATCA reporting code, later, and the Instructions for the Requester of Form W-9 for more information.

#### **Updating Your Information**

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you are no longer tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust dies.

#### **Penalties**

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

#### Specific Instructions

#### Line 1

- Partnership, C corporation, S corporation, or LLC, other than a disregarded entity. Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2.
- Other entities. Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. Enter any business, trade, or DBA name on line 2.
- Disregarded entity. In general, a business entity that has a single owner, including an LLC, and is not a corporation, is disregarded as an entity separate from its owner (a disregarded entity). #### **GENERAL CONDITIONS**

#### B-1 CONSIDERATION OF BIDS.

All bids received in conformity with the Invitation to Bid shall be endorsed with the contract or advertisement name or number and name and address of the bidder. All bids, immediately after being read, shall be tabulated and summarized and shall become public record in the office of the Commissioner of Purchases and Supplies.

#### B-2 UNACCEPTABLE BIDS.

No bid will be accepted from, nor a contract awarded to, any person, firm or corporation that is in arrears or is in default to the City upon any debt or contract, or is a defaulter as surety or otherwise upon any obligation to the City, or has failed to perform faithfully on any previous contract with the City of Cleveland.

#### B-3 REJECTION OR ACCEPTANCE OF BIDS.

The City through the Board of Control shall have the right to reject any or all bids, parts of such bid, and reserves the right to waive any informalities in the bid. In addition to bid price and discount, the City reserves the right to consider all elements entering into the question of determining the responsibility of the bidder. Any bid which is incomplete, conditional, obscure, contains additions not called for, or irregularities of any kind, may be cause for rejection of the bid.

# B-4 EVIDENCE OF ABILITY TO FULFILL CONTRACT.

Bidders must present evidence to the Commissioner of Purchases and Supplies, when required by him to do so, to show they are fully competent and have the necessary source of supply, facilities and pecuniary resources to fulfill the conditions of the contract and specifications.

#### B-5 WITHDRAWAL OF BID.

No bid may be withdrawn after it has been deposited with the Commissioner of Purchases and Supplies.

#### B-6 TIME OF AWARD.

The Board of Control of the City of Cleveland shall make an award or reject all bids not later than the second regular meeting of said Board following the opening of bids, unless further time is required to analyze bids, to investigate responsibility of any bidder, or in the absence of a time limitation for acceptance set forth in the bid.

Any extension of time beyond the date fixed by the successful bidder or the fourth regular meeting of the Board of Control, whichever event shall occur first, shall be subject to agreement between said bidder and the Board.

#### B-7 AWARD CONTRACT.

No contract shall be awarded without the approval of the Board of Control, and then only to the lowest and best bidder.

#### B-8 PERFORMANCE BOND.

A. Contracts for the purchase of articles, supplies, commodities, materials, equipment or services shall be secured by a bond in the form and content prescribed by and acceptable to the Director of Law, with good and sufficient sureties and in an amount equal to at least twenty-five percent (25%) of the contract price on materials supplied and at least fifty percent (50%) of the contract price on services supplied. A check is not acceptable in place of a performance bond. A performance bond is not required for standard purchase and requirements contracts awarded in the amount of \$500,000.00 or less, except that standard purchase and requirements contracts that are labor and materials contracts including, but not limited to painting, carpentry, plumbing, electrical, masonry, landscaping, snow plowing, fencing and trucking over \$100, 000 but not more than \$250,000 shall require a bond of at least twenty-five percent of the contract price, and over \$250,000 but not more than \$500,000 shall require a bond of at least fifty percent of the contract price. The above policy notwithstanding, the City of Cleveland reserves the right to require a performance bond in various amounts or to modify the performance bond requirement whenever it is determined to be in the best interest of the City of Cleveland to do so.

B. No performance bond will be required on any contract in the amount of \$100,000 or less issued pursuant to this Invitation to Bid (ITB). Any contract over \$100, 000 but not more than \$250,000 shall require a bond of twenty-five percent (25%) of the contract price, and any contract over \$250,000 shall require a bond of fifty percent (50%).

#### B-9 RELEASE OF BOND.

Whenever a performance bond is required, the performance bond will not be released until all the provisions of the contract have been fulfilled.

## B-10 CANCELLATION OF CONTRACT.

The City shall have the right to cancel this contract on five (5) days written notice if, in the opinion the Commissioner of Purchases and Supplies, the delivery of materials, supplies or equipment or the performance of work or services are not in accordance with contract specifications and the contractor fails to cure such deficiencies or comply with the contract specifications within ten (10) days after receipt of notice of default from the City, except where fulfillment of its obligation requires activity over a period of time and it has, within ten (10) days of the default notice commenced such activity. Additionally, the City shall have the right to cancel this contract, without cause, upon fifteen (15) days written notice upon the determination of the Board of Control of the City, expressed through its resolution, to do so.

## B-11 SUBCONTRACTING OR ASSIGNMENT OF CONTRACT.

a. The contractor shall not subcontract, sublet, assign, transfer, convey or otherwise dispose of the contract, its duties, rights, title or interest in it or in any part thereof, or assign, by power of attorney or otherwise, any of the monies due or to become due under the contract, except, in each instance, with the prior written authorization of the Board of Control of the City, expressed through its resolution, and then only upon such terms and conditions as may be agreed to by said Board. No such subcontracting, subletting, assignment, transfer, conveyance or other disposal of the contract shall be valid until filed in the office of the Commissioner of Accounts.

- b. Prior written Board of Control consent is required for a City contractor to add a subcontractor, or to substitute one subcontractor for another subcontractor, under a City contract.
- c. The City assumes no obligation to pay, and will not pay, a contractor for any work and or services performed by a sub-contractor on the contract prior to Board of Control approval of that sub-contractor.
- d. The Director will not grant any City contractor additional time to meet project deadlines, and will not authorize or pay additional compensation or delay damages of any kind arising from the contractor's inability to add or substitute a subcontractor because the contractor failed to submit the approval request and supporting documentation at least 3 (three) weeks in advance of the date the additional or substitute sub-contractor is needed.
- e. The Office of Equal Opportunity shall evaluate each subcontractor addition and substitution for increased CSB, MBE, or FBE participation even if the original contract had no certified sub-contractor participation.
- f. The City's <u>Sub-contractor Addition and Substitution Policy and Procedure</u> is hereby incorporated by reference in its entirety. The complete document is available online at the City of Cleveland website: <a href="http://www.city.cleveland.oh.us">http://www.city.cleveland.oh.us</a>.

# B-12 DELAY FOR CAUSES BEYOND CONTROL.

If the contractor is delayed in complying with the terms of the contract by strikes, lockouts, fire, unusual delay by common carriers, unavoidable casualties, or any cause beyond the contractor's control including orders, limitations or restrictions of any Governmental agency having jurisdiction over the subject matter of the contract, or by delay authorized by the City, or for any cause by which the director shall decide to justify the delay; then for all such delays and suspensions, the contractor shall be allowed one calendar day extension beyond the time fixed for compliance with the terms of the contract for each and every calendar day of such delay so caused in the completion of the work, the same to be ascertained by the director.

#### B-13 PATENTS.

The Contractor shall be required to pay all royalties and license fees and shall hold and save the City and its officers, agents, servants and employees harmless from liability of any nature or kind, including cost and expenses, for or on account of any patented or unpatented invention, process, article, or appliance manufactured or used in the performance of the contract, including its use by the City of Cleveland unless otherwise specifically stipulated in the contract documents. In this respect the contractor shall defend all suits or claims for infringement of any patent or license rights.

#### B-14 DELIVERY.

The vendor shall adhere to all stipulated delivery terms (e.g., material / service delivery upon a pre-set schedule, upon orders being placed, etc.). All service performance / material deliveries should be made <u>only if</u> the City of Cleveland has issued a valid, open Pyrchase Order (PO) with a sufficient free balance to

cover the <u>full</u> costs of the service being performed or materials being delivered. The City will not pay vendors for goods or services that are either delivered to the City under an invalid or unauthorized PO or were ordered using an expired contract. The City is not responsible for, and will not pay for, goods or services delivered to the City that are not authorized under the PO and contract under which a sale was purportedly made. Therefore, the vendor <u>must not</u> perform any services nor deliver any materials without a valid, open PO that authorizes the services / materials and that carries a sufficient free balance to cover the services / materials.

Upon delivery, some form of delivery documentation must be left with the City of Cleveland Department. For service performed, some Proof of Service documentation must be given to a City employee. For materials delivered, some Proof of Delivery or Packing Slip must be given to a City employee. In all instances, the delivery documentation must be signed and dated by a City employee in order to substantiate the services provided or materials delivered were as indicated on the documentation. City employees are charged with performing this verification, so vendors should allow adequate time for this review to occur. Failure to provide some delivery documentation, which received a City signature and date upon delivery, may result in payment delays.

#### B-15 LABORATORY TEST.

The City of Cleveland reserves the right to test all materials, equipment or supplies delivered during the life of the contract, at an independent laboratory to be designated by the Commissioner of Purchases and Supplies of the City of Cleveland. Where the result of such test shows the materials, equipment or supplies are not equal to the specifications, then the expense of making such test shall be paid by the contractor.

## B-16 FAILURE TO MEET SPECIFICATIONS.

The delivery of any material, supplies or equipment or the performance of any work or services under the contract which do not conform to contract specifications will be rejected and the contractor notified immediately in writing of such rejection and the reason therefore. If the time for performance has not expired, and the contractor wishes to remedy the deficient materials, supplies or equipment or performance, it may notify the Commissioner of Purchases and Supplies of its intention to cure and may within ten (10) days make a conforming delivery of performance unless such time is extended in writing by said Commissioner. If said contractor fails to replace such nonconforming materials, supplies or equipment or otherwise cure such deficient performance of work or services, the City of Cleveland will purchase such materials, supplies or equipment or obtain the performance of such work or services of the character required on the open market or in case of work and services, by performance by City employees. In such event, the contractor and his surety shall be liable to the City for any excess costs and expenses thereby incurred.

#### B-17 SAFEGUARDS.

Any equipment to be furnished by the terms of this bid, shall be provided with safety controls, guards, and housing meeting the requirements of the safety standards of the Industrial Commission and the Department of Industrial Relations of Ohio, and the cost shall be included as part of the bid.

#### B-18 STATE OR FEDERAL TAXES.

- a. The City of Cleveland is exempt form all sales, excise and transportation taxes, except State of Ohio gasoline tax. The price or prices bid shall be exclusive of all such taxes and will be so construed.
- b. The contract price is subject to increase by the amount of any additional tax imposed by the Federal Government or the State of Ohio subsequent to the receipt of bids. Such claim for increased prices must be presented to the City within thirty (30) days after such tax becomes effective and supported by evidence salisfactory to the Director of Law.
- c. The contract price is subject to reduction by that amount by which an applicable tax is reduced during the period of the contract.

# B-19 SOCIAL SECURITIES ACT/EMPLOYEES BENEFIT PAYMENTS.

The contractor shall be and remain an Independent contractor with respect to all services performed under said contract, and agrees to and accepts full and exclusive liability for the payment of any and all contributions or taxes for social security, unemployment insurance, old age retirement benefits, pensions, or annuities now or hereafter imposed under any state or federal law, which are measured by the terms of this contract and further agrees to obey all lawful rules and regulations and to meet all lawful requirements which are now or hereafter may be issued or promulgated under said respective laws by and duly authorized state or federal officials and said contractor also agrees to Indemnify and save harmless the City of Cleveland from an such contributions or taxes or liability therefore.

# B-20 FREIGHT ON DIRECT SHIPMENTS TO THE CITY.

The freight prices made in the bid are to be in accordance with tawful freight or cartage charges in existence at the time the bid is made, and contract prices shall be increased or decreased by changes in the freight or cartage rates, provided that claims for additional freight or cartage be presented to the City of Cleveland within thirty (30) days after said advance in freight or cartage rates becomes effective. Reductions in freight or cartage prices will be deducted from the contract price.

#### B-21 INVOICING AND PAYMENT.

The Contractor shall submit invoices that appropriately reflect the work performed. Original Invoices must be typed and legible. The City of Cleveland does not pay from duplicates or copies. Each invoice must be malled as specified below:

- Optional: Copy of invoice to the City of Cleveland, Division of Accounts, 601 Lakeside Avenue, Cleveland, OH 44114, clearly marked "COPY".
- Address invoice questions first to the ordering department. The Division of Accounts will assist if the Department is unable to resolve the question.

The failure to deliver copies of invoices to the indicated location may lead to delays in payment.

Invoices submitted by the Contractor for payment <u>must</u> include the following information:

  - Date that work was performed / material delivered,
  - Location for each Item of service performed / material delivered.
  - Line Item Number from the Contract's Schedule of Items (SOI) that is being involced,
  - Quantity of items being invoiced under each Line Item.
  - Unit Cost of each Line Item.
  - Extended Cost by each Line Item.
- delivery documentation (e.g., Proof of Service / Delivery slip, Packing Slip, etc.) with an acknowledgement signature and date from a City of Cleveland employee;

The City of Cleveland is not subject to sales tax per Section 5739.01 (B)(1) O.R.C. Therefore invoices must not charge sales tax. The City's Tax Exemption Number is 34-6000646. Tax Exemption Certificates are available upon request from the Division of Purchases and Supplies.

Any applicable discounts, as stipulated through the contract and/or PO, must be itemized and applied to the invoice. Any special instructions contained within the contract must also be followed.

If any invoice is erroneous or does not include the above required information, the City shall inform the supplier as to the reasons thereof and any corrective actions necessary to qualify the invoice for payment by the City. The vendor is responsible for providing the delivery documentation at the time of delivery and for submitting the invoice.

#### B-22 EQUAL OPPORTUNITY.

This contract is a contract, and contractor is a contractor within the meaning of Chapter 187 of the Codified Ordinances of Cleveland, Ohio 1976. During the term, the contractor shall comply with all terms, conditions and requirements imposed on "contractor" in the Equal Opportunity Clause, Section 187.22(b) of

the Codified Ordinances of Cleveland, Ohio 1976, attached hereto and made a part hereof. A copy of such clause shall be made a part of every subcontract of agreement entered into for goods or services and shall be binding on all persons, firms and corporations with whom the contractor may deal.

PARAGRAPHS B-23 AND B-24 APPLY ONLY IF THE REQUIREMENT CONTRACT BID BLOCK IS MARKED ON BID PAGE 1 OF BID AND ON BID FORM.

#### B-23 DURATION OF CONTRACT.

The proposed contract shall be effective upon its execution and approval by the Director of Law of the City of Cleveland and, for the purpose of accepting delivery, shall continue in full force and effect for the period specified in the specifications and/or the Schedule of Items section of the bid, unless otherwise indicated.

#### B-24 REDUCTION IN PRICES.

The contractor agrees that if the price to the general trade is reduced while the contract is in effect, the City of Cleveland will receive the benefit of such reduction immediately. However, if the contract price is below the price to the general trade at the time the contract is awarded, the reduction provision will be effective only when the recognized price to the general trade reaches a level lower than the contract price or when the contractor reduces his own price to a level lower than the contract price.

B-25 EIGHT-HOUR DAY, MINIMUM WAGE, AND NON-DISCRIMINATION.

The Contractor agrees that it shall comply with the following provisions of the Charter of the City of Cleveland, which are, respectively, as follows:

Section 196. Except in case of extraordinary emergencies; not to exceed eight (8) hours will constitute a day's work and not to exceed forty eight (48) hours a week's work, for any City employee of the City of Cleveland in the classified service thereof, and for any workmen engaged in public work carried on or aided by the municipality whether done by contract or otherwise. The Council shall by ordinance, provide for the enforcement of the provisions of this section.

Section 197. Every contract for public work entered into by the City of Cleveland shall contain, and no contract shall be entered into unless it contains the following stipulations:

The Contractor hereby agrees that all persons employed by him will be paid wages which are not less than are paid by the City of Cleveland for similar or like work; but it said City has not established a rate of wages for any particular class of work to be performed under the terms of this contract, then said employees shall be paid wages not less than are generally paid therefore by others employing union labor in said City.

The Contractor hereby further agrees that in the employment of labor, skilled or unskilled, under the Contract there will be no discrimination exercised against any citizen because of race, color, religion or national origin; and that any violation hereof shall be deemed a material breach of said contract.

#### B-26 LAWS, PERMITS, AND REGULATIONS

The contractor shall comply with all applicable laws of the Federal government, State, ordinances of the City or other municipality in which the work or services are being done and all applicable regulations and any authorized regulations, and shall be responsible for securing at his own expense any and all licenses, permits and certificates of inspection required by law or by the contract documents.

## SERVICES, LABOR & MATERIALS - IF THIS CONTRACT IS FOR WORK, SERVICES, OR LABOR & MATERIALS, B-27, 28 AND B-29 APPLY

## B-27 STATE INDUSTRIAL COMPENSATION FOR PURCHASE OF LABOR AND MATERIALS.

If this contract contains labor, whether in part or in all, the contractor shall, in all cases during the term of this contract, subscribe to and comply with the Worker's Compensation Laws of the State of Ohio and pay such premiums as may be required thereunder and to save said City harmless from any and all liability arising from said act. He shall also furnish at the time of delivery of this contract and such other times as may be requested, a copy of the official certificate or receipt showing the payments hereinbefore referred to. A copy of the official certificate or receipt showing the payments hereinbefore referred to, shall be submitted with the bid, or, if not included with the bid, shall be submitted with the signed contract. No work shall be commenced, or payments made, until the certificate or receipt is received by the City. The contractor shall maintain continuous coverage throughout the contract and shall notify the City in writing within 24 hours of receipt of notice of cancellation or reduction of coverage.

#### B-28 INDEMNITY

Contractor shall indemnify, defend, and hold harmless the City of Cleveland, Ohlo, its officers, agents, and employees from all claims, demands, llabilities, loss, suits, causes of action, judgments, costs, and expenses, including attorneys' fees, arising, occurring, or allegedly arising or occurring from personal injury, including death, property damage, including loss of use, or otherwise, to any person or the property of any person, including third parties and employees of any party, as a result of negligent or intentional act or omission by Contractor or its agents, employees, subcontractors or suppliers, in performing work or services or furnishing labor and materials under this contract. This indemnification right is in addition to any other indemnification or contribution right of any indemnified party and shall survive completion of the work or services or furnishing of labor and materials.

#### B-29 WARRANTY

Contractor warrants, in addition to any other express or implied warranty required by law or the contract, that all work and services performed under this Agreement will be of good quality, free from faults and defects, conform to the contract documents, performed in a workmanlike manner according to good usage and

accepted practice, resulting in a merchantable product, and fit and suitable for their intended purpose, and that materials supplied will be of good quality and free from all defects, latent or patent.

#### B-30 OHIO CAMPAIGN FINANCE LAW

Pursuant to the Ohio Revised Code, as referenced below, the following language is hereby made a part of this document:

"Contractor hereby certifies that beginning on the date the contract is awarded and extending until one year following conclusion of the contract, all persons identified in Ohio Revised Code Sections 3517.13(I)(3) and 3517.13(J)(3), as applicable, are in compliance with Ohio Revised Code Sections 3517.13(I)(1) and 3517.13(J)(1)."

Cleveland Public Power may request the selected vendor (s) to provide reports on an asneeded basis, that account for the quantity of items ordered, along with the cost per item charged. The financial report will help to identify most frequently ordered items and also allow accurate monitoring of year-to-date spending against the overall contract amount.

They are not guaranteed to be accurate statements and quantities to be performed or furnished under this contract, and any departure there from will not be considered as valid grounds for any claims for damage or for loss of profits. CPP reserves the right to procure more or less than shown under the terms of this requirement contract.

#### C.5. UNIT PRICES

All prices quoted shall be on a per unit basis as indicated on the Bid - Schedule of Items pages and shall include all costs for handling and delivery, F.O.B. point of delivery. Bid prices shall be good for the period of two years. Such time period shall commence upon the date of the signed contract.

#### C.6. PARTS, MATERIALS, AND SUPPLIES

Parts, Materials, and Supplies to be purchased under this contract will be obtained through an allowance in the amount not to exceed \$240,000.00, per line Item #4 of the Bid – Schedule of Items pages, unless otherwise determined by CPP. all parts, materials and supplies purchased under the contract.

#### C.7. DISCOUNT FROM LIST PRICE

Bidders must show a percentage off list prices or enter a "zero" in the space provided on the Bid – Schedule of Items page, if no discount is offered. The City will then interpret this to mean that items will be sold to the City at "cost". Any discount not clearly stated will be disregarded in determining the lowest and best bid, and the price quoted will be considered a net price. To ensure a truly competitive bid, parts discount where applicable will always be discounted from original equipment manufacturers current list price schedules and aftermarket manufacturer's price schedules. Bidders must have access to all manufacturers' materials immediately as needed. Bidder will provide manufacturer's price pages so discounts can be verified, at the time of request for quotation. Bidders will not use any type of price list they have prepared for their business. All prices must be from a bona fide manufacturer of the parts, materials, equipment, service, and/or supplies. Original equipment manufacturers' products will be used in the vast majority of cases.

However, there may be some exceptions. Should a substitute manufacturer's items be of equal quality and significantly lower in cost, CPP may approve its use. However, the bidder will never make this assumption without approval. Any substitutions of OEM items must be approved by CPP. Furthermore, the bidder will never attempt to provide a substitute manufacturer's item as a means of realizing a greater profit as the expense of the City of Cleveland.

#### C.8. MARKUP FROM INVOICE COST

Cleveland Public Power will recommend the rejection of bids for improper submittal of documentation, incomplete submittal of documentation and/or unsubstantiated information within the submittal. Performance, cost, timeliness and safety shall be considered as the essence of the contract and/or contracts.

#### C.10. MATHEMATICAL ERRORS

- A. If a bidder makes any mathematical errors in the bid sheets such that some or all of the bid numbers are mathematically inconsistent with each other, the City shall correct such errors as follows. The lowest level values or unit prices shall be deemed as indicating the bidder's true intent and shall be accepted as correct. All further calculations shall then be corrected, and these corrected values shall be cascaded throughout the entire set of bid sheets, potentially affecting the bidder's final bid price. Calculations subject to such correction include, but are not limited to:
  - 1. The summing of labor and material unit prices into a total unit price.
  - 2. The multiplication of unit price times quantity to arrive at the extension cost.
  - 3. The summing of individual line items into totals or subtotals.
  - 4. The multiplication of any subtotals or other values by contingency percentages or other factors, if contingency allowance applies.
  - 5. The transferring of subtotals or values from one sheet to another.
  - B. If the correction of any errors has an effect on the award of the contract, only the directly affected bidders will be notified in writing of the corrections and their affects.

#### C.11. METHOD OF AWARD

The City reserves the right to award a single contract for all items, or by individual items to the lowest and best bidder based on price, delivery time, discount offered and conformance to specifications as deemed advantageous after evaluation by the City.

#### C.12. GUARANTEE

The bidder shall guarantee that the materials as furnished by him shall be free from all inherent defects of design, materials and workmanship for a period of one year after delivery. He shall rectify, entirely at his own expense, any inherent defects that may develop in the said guarantee period.

#### C.13. METHOD OF SHIPMENT

All items shall be shipped as standard packages, except as noted on Delivery Orders, properly wrapped and identified.

#### C.14. DELIVERY

All items to be furnished and as ordered under the terms of these specifications shall be delivered between the hours of 8:30 A.M. to 3:30 P.M., Monday thru Friday, to the location listed on the Delivery Order (DO).

To facilitate unloading, all items of a size which make them hard to handle or are fairly heavy are to be delivered in open trucks without any additional charges. Cleveland Public power may refuse delivery of any items that do not meet the conditions stated above.

#### C.15. NO WAIVER OF LEGAL RIGHTS

Neither acceptance of nor payments for the works of goods or service hereunder, or any part of them, nor any extension of time, nor any possession taken by the City shall operate as a waiver of any portion of the Contract, nor shall a waiver or any default or breach or the Contract be held to be a waiver of any other or subsequent default or breach.

#### **C.16. REQUESTS FOR FINANCIAL REPORTS**

Cleveland Public Power may request the selected vendor (s) to provide reports on an asneeded basis, that account for the quantity of items ordered, along with the cost per item charged. The financial report will help to identify most frequently ordered items and also allow accurate monitoring of year-to-date spending against the overall contract amount.

#### SECTION C - SUPPLEMENTAL GENERAL CONDITIONS

#### C.17. LIABILITY

Vendor assumes all liability with regards to insurance while in the custody of their employees; thereby holding the City of Cleveland harmless for damages to personal property, real property and personal injuries.

### **C.18. INSURANCE REQUIREMENTS**

Insurance shall be in such form as will protect the Contractor from all claims and liabilities for damages for bodily injury, including accidental death, and for property damage, which may arise from operations under this contract whether such operations by himself of any anyone directly or indirectly employed by him.

#### **AMOUNT OF INSURANCE**

- A) Comprehensive General Liability: Bodily Injury or Property damage \$1,000,000.00 each occurrence and general aggregate.
- B) Automobile and Truck Liability: Bodily Injury or Property Damage \$1,000,000.00 each occurrence and general aggregate.

Comprehensive General Liability coverage and Automobile and Truck Liability coverage may be met with a combination of coverage including excess and umbrella liability coverage. Coverage must also explicitly cover all containers and other equipment used in the performance of this contract.

#### **TYPES OF INSURANCE FOR CONTRACTORS**

Purchase and maintain the following types of insurance:

- A) Full Workman's Compensation Insurance coverage for all people employed by the Contractor to perform work on this project. This insurance shall be in the amount of \$500,000.00 for each accident, illness or disease or such other amount that may be required by the most current laws of the State of Ohio, whichever is greater.
- B) Comprehensive General Liability Insurance covering bodily injuries and property Damage shall also include coverage for:

- C) Automobile and Truck Liability covering bodily injury and property damage covering the operations of all motor vehicles and equipment, whether or not owned by the Contractor, being operated in connection with the prosecution of the work under this Contract.
- D) Product and Completed Operations coverage to be included in the amounts specified above in Comprehensive General Liability.

#### C.19. EVIDENCE OF INSURANCE

The Contractor shall submit all required insurance certificates to the City at the time of execution of the Contract. No work may start until the Contractor has provided the requisite proof of insurance. The City is to be included on each policy as an additional Insured. The Contractor shall notify the City in writing at least 30 days before it cancels or reduces its insurance policy or coverage and immediately upon the Company's receipt of notice from an insurance policy of any cancellation or reduction of the coverage or police.

#### C.20. INVOICING AND PAYMENT (Supplemental to General Condition B-21)

### A) INVOICING

The vendor shall submit invoices that appropriately reflect the material provided. Invoices must be typed and legible. Each invoice must be mailed as specified below:

  - c. Include the part number(s), and manufacturer name of the materials, quantity shipped, the date of shipment, the date of billing, the company name, the release order number, location shipped to, the description of the activity, applicable discount or markup and extension, to include City's actual cost.
  - d. Payment requests shall be submitted monthly reflecting work performed during the previous month and shall be an "Aging Invoice" statement. Invoices shall be submitted as appropriate to the terms of the purchase or repair.
  - e. The bidder must provide firm documentation of the invoice cost from item(s) being purchases at the time of the transaction or with the invoice. The bidder will then apply their quoted discount or markup to arrive at the City of Cleveland, Division of Cleveland Public Power's actual cost. All invoices must include both invoice cost and City of Cleveland cost after markup is applied. The bidder is advised that invoices will not be paid unless they are submitted as specified.

#### B. PAYMENT

- 1. The vendor must adhere to the terms set forth above and under C-13 Delivery and C-19 Invoicing. CPP will review invoices upon receiving them. In order to perform this review, CPP requires all of the following documents;

The vendor is responsible for providing the delivery documentation at the time of delivery and for submitting the invoice. The City will provide the contract and DO copies. A CPP employee will use the above four documents to perform cross-checks to ensure accuracy in invoicing. If all is in order (e.g., delivered / invoiced items were authorized under the contract and DO, invoice quantities were delivered, contract prices were invoiced, discounts applied, etc.), CPP will approve payment of the invoice through the City's internal processes. The City's Division of Account subsequently handles processing of the payment request, and the Division of Treasury issues the payment.

### C.21. OEO PARTICIPATION GOALS (Supplemental to A-18 and A-19)

Under Chapter 187.13C of the Codified Ordinances, the OEO participation goal for this Requirement contract has been waived. See Subcontractors Notice for details.

### C.22. FAIR EMPLOYMENT WAGE LAW REQUIREMENTS

The Fair Employment Law is applicable for this ITB. The aggregate value of the Service to be performed is estimated to be least \$25,000.00.

Bidders must read and complete the enclosed Fair Employment Wage schedules therein. Failure to comply may result in the rejection of the bidder's response.

#### **TESTING AND INSPECTION**

Testing and Inspection shall include the following:

All labor and materials necessary for the testing and inspection at high voltage levels and the maintenance of hydraulic aerial bucket trucks and digger trucks as required by the City of Cleveland, Division of Cleveland Public Power.

All work to be performed in accordance with Occupational Safety and Health Act (OSHA) standards and the American National Standard Institute (ANSI), "Standard for Vehicle-Mounted elevating and rotating work platforms". **NOTE: All test procedures outlined in these specifications per ANSI A-92.2 1990 and related subsequent updates to these procedures.** 

#### **D.1. LOADING TEST**

The contractor shall perform a loading test (on a vehicle or test stand) on each aerial device manufactured. This test shall include the movement of the platform (with an imposed) through its entire range of motion.

#### a. VISUAL INSPECTION

Thereafter a final visual inspection of the finished article shall be made to determine whether the loading test had produced an adverse effect in any component.

#### D.2. QUALITY CONTROL

The contractor shall use a uniform method of quality control to insure compliance with its standard and with his own standards.

#### D.3. MOUNTED AERIAL DEVICE

Whoever mounts an aerial device upon a vehicle (whether it be the manufacturer, dealer or purchaser) shall, before the unit is placed in operation, perform stability test in accordance with the requirements of 3.1.5 and 3.1.6 of the ANSI Standard. Therefore, the contractor shall make a visual inspection of all accessible components for evidence of defects such as loose connections hydraulic

leaks, frayed wire rope, deformation of any component hydraulic leaks and other items specified in the manufacturer's operating manual. Vendor to provide evidence of the test performed.

#### **D.4. INSULATION TESTS**

Any aerial device or component thereof, which is represented by the manufacturing or installer, as being insulated shall meet the requirements of 6.A.3 of the ANSI Standard.

#### D.5. ELECTRICAL TEST ON INSULATED DEVICES

- A. Test equipment shall meet the requirements of American National Standard Techniques for Dielectrical Tests, C68.1 1968, of the latest revision thereof, suggestions as to voltage, source voltage, voltage control, protection voltage measurement are set forth below:
  - A voltmeter used in conjunction with a calibrated instrument potential transformer connected directly across the high-voltage circuit.
  - 2) A calibrated electrostatic voltmeter connected directly across the high voltage circuit.
  - 3) A voltmeter connected to a well-designed tertiary coil in the test transformer, provided it has been demonstrated that the assigned ratio of transformation does not charge appreciably with load.
  - 4) A calibrated potential divider (Resistive or Capacitive)

#### D.6. CURRENT MEASUREMENT

The current should be measured with an AC ammeter, or an equivalent, non-inductive shunt and a voltmeter, connected in series with specimen. The lead from the specimen to the ammeter shall be shielded.

#### **D.7. TEST PROCEDURES**

#### A. TEST VOLTAGE

Test voltage shall be applied to upper electrode of the insulated boom at a low voltage and steadily raised until the prescribed test is reached. This voltage shall be maintained for prescribed test period. The current shall be recorded at the beginning and at the (end of the) test period. Or (...throughout the entire test period.)

#### D.8. TEST (referenced are to the ANSI Standard)

#### A. INSULATED BOOM ASSEMBLY

The assembled aerial device in operable condition shall be tested on a grounded vehicle or a grounded test stand. The voltage shall be applied to the upper electrode of the insulated boom, and the lower end of the insulated boom, shall be connected to ground potential (See 4.11 and Fig. 1, Total Arm Current). The locations of the electrodes shall be permanently marked or recorded to facilitate repeating future test of apparatus. Appropriate test voltages shall be applied to the values in Table 1.

With electrodes as described in 4.11, test shall consist of rated, double rated, and at the manufacturer's option either momentary withstand or switched surge voltage (See Footnote Table).

1) The voltage is raised to rated voltage and the current recorder. The voltage is then raised to double-rated voltage and held for three minutes, recording the current at the start and the end of three-minute test period during which the current shall neither increase more than 10% nor exceed the values given in Table 1. The switching surge withstand test shall be in accordance with American National Standard.

Dielectric Test - All dielectric tests shall be performed in accordance with the techniques for Dielectric Tests, C68.1-1968, or the latest revision thereof.

#### D.9. TRANSFORMER

The prescribed test voltage can be most readily obtained from a step-up transformer energized from a variable low voltage source. The transformer and its control equipment should be of such size and design that, with the test specimen in circuit, the crest factor (Ratio of maximum to effective value of the test voltage) shall not differ more than +5% from that of a sinusoidal wave being 1.414. The crest factor may be checked by reading of a crest-reading voltmeter in connection with an instrument potential transformer is connected across the high voltage circuit, a standard sphere gap may be used for measurement of the crest valve and compared with reading of AC voltmeter.

#### **D.10. CIRCUIT BREAKER**

The test transformer circuit should be protected by an automatic circuit - breaker device designed to open the circuit promptly by the high current due to breakdown or flashover.

#### **D.11. VOLTAGE CONTROL**

Control of voltage can be secured in one of several ways:

- 1) Induction Regulator
- 2) Variable-Ratio Auto Transformer
- 3) Generator Filed Regulation

Preference should be given to equipment producing no voltage distortion and having an approximately straight-line voltage time or voltage displacement curve over the operating range. Motor drive the regulating equipment is convenient to use and tends to give uniform rate-of-rise to the test voltage.

#### **D.12. VOLTAGE MEASUREMENT**

The voltage should be measured by a method, which gives correct effective values of the voltages actually applied to the aerial device. Approved methods are:

- 1) A voltmeter used in conjunction with a calibrated instrument potential transformer connected directly across the high-voltage circuit.
- 2) A calibrated electrostatic voltmeter connected directly across the high voltage circuit.
- 3) A voltmeter connected to a well-designed tertiary coil in the test transformer, provided it has been demonstrated that the assigned ratio of transformation does not change appreciably with load.
- 4) A calibrated potential divider (Resistive or Capacitive)

## D.13. CONTRACTOR'S CERTIFICATION TEST FOR INSULATED UNITS UNDER 69KV

Units for use under 69 KV do not require permanent electrodes. They shall be tested by insulating the vehicle and connecting it to ground through the current meter. They shall be tested at 100 KV 60 Hz (Hertz) for three minutes and the current shall not exceed one milliampere. This current will be largely capacitive, and therefore, will not be consistent with valves required where permanent electrodes are used. The test equipment and procedures shall confirm with all applicable portions of 5.1 through 5.5.3.1 of the ANSI Standard.

# A. AERIAL, ELBOW, FIBERGLASS, BOOM, LOWER BOOM, BUCKET, PEDESTAL INSPECTION.

The contractor shall perform the following testing and inspection procedures, inspect aerial elbow complete, including fiberglass boom, upper boom, steel lower boom, bucket, pedestal and mounting.

- Check hydraulic pump for pressure and flow with flow meter.
- Check main hydraulic relief valve, adjust hydraulic pressure to factory specifications. Change hydraulic filter and clean strainers.
- Operate elbow from lower controls check lower controls override.
- Structurally test elbow for maximum load capacity on both sides of the cylinder.
- Inspect elbow complete with suspended rate load.

- Clean upper fiberglass insert (if required).
- Electrically test upper fiberglass boom for 100KV-AC and certified for 69KV.
- Test lower fiberglass insert to manufacturer's specification.
- Test report for both booms must be furnished with leakage of boom listed.
- Operate complete elbow in all functions and make list of all needed repairs
- Check complete unit for any factor engineering up-date factory work

Supply a complete checklist on each unit for any and all repairs needed or suggested repairs to maintain the units in the best working conditions.

All work must be performed by a factory authorized dealer or someone manufacturing or installing utility type equipment. All parts for aerial elbows must be manufacturing standard parts. All work must be performed by a factory-trained technician. Copies of training certificates must be supplied with the bid or it will be rejected. No Exceptions. The vendor must also employ a certified Fluid Power Specialist. A copy of the certificate from the Fluid Power Society must be supplied with the bid or it will be rejected. No Exceptions.

Remanufactured or homemade parts items will not be acceptable.

Contractor must have and maintain an inventory of required service parts for the equipment of the Cleveland Public Power System, which consists of the attached equipment list. Said inventory is subject to an inspection by Cleveland Public Power. CPP will perform its own engine, transmission and standard truck equipment repairs.

This specification is intended to apply to the maintenance of the evacuating and rotating equipment and associated hydraulic systems.

## B. UTILITY DERRICK DIGGER TRUCK INSPECTION AND TEST PROCEDURES

Visually inspect complete hydraulic boom, pedestal and mounting

- Check hydraulic relief valve for operation and pressure setting.
- With derrick on test pad, test derrick maximum lift at 75 degrees and at 0 degrees with all booms retracted.
- While derrick is under tension, inspect derrick structure for any crack or breaks.
- Dynamometer test results must be listed.
- Inspect derrick rotation bearing with dial indicator for wear.
- Check derrick rotation gearbox wear and adjustment.
- Inspect derrick hydraulic side pull protection (if equipped) open and inspect derrick rotation brake, check derrick brake disc and install new oil. Reassemble brake and adjust to correct side pull release. Side pull is to be tested with dynamometer and pounds of side pull listed.

#### C. BOOM WINCH TEST

Operate boom winch check for capacity of winch and check winch brake. Remove and inspect winch rope or cable for attachment and excessive wear.

List results of boom winch pull.

#### D. DIGGER TEST

- Remove auger from Kelly bar
- Install Kelly bar in test tube winch dynamometer attached to test rig. Pull test digger

For each unit, supply a complete list of any and all repairs needed or suggested to maintain the units in the best working condition.

All work should be performed by a factory authorized dealer or someone manufacturing or installing utility type equipment. All parts for hydraulic derrick, digger and winch must be manufacturers standard parts. *Remanufactured or homemade parts will not be acceptable.* All work must be performed by factory certified technician copy of current certificates must be submitted with bid or it will be rejected. If certificates are old, vendor must provide a schedule to update training of technician to comply with newer truck models.

#### **D.14. CERTIFICATION**

For each truck repaired at the request of Cleveland Public Power, the contractor shall provide Cleveland Public Power with a certified written report covering the testing and inspection in accordance with Section 5 ANSI Standards.

#### **D.15. QUALIFICATIONS VENDORS TO MEET**

1. To reduce road miles accumulated on a unit and control cost of travel, (chassis related and labor hours) vendor must be located within a radius of 40 miles of the City's service center. Vendor to provide and deliver to Cleveland Public Power at no charge, this includes both West 41 Street and E 140th Street service centers.

- Vendor must have factory-trained mechanics who have been trained by an original equipment manufacturer for the proper hydraulic electrical and structural repairs.
- Vendor must employ at least one Fluid Power Specialist certified technician. A copy of the certificate must be supplied with bid or the bid will be rejected.
- 4. Vendor must be able to perform Dielectrical testing and all other relating type testing outlined in this contract at either the 2490 West 41st or 743 E 140th Street service centers. This is to minimize down time of vehicles. Any vehicle that fails testing will be taken to contractor's establishment to be fixed and retested for certification and returned to applicable service center as soon as possible.
- 5. Vendor must have on site Dielectrical testing apparatus and trained operators.
- 6. Vendor must have an established road service program, that includes a vehicle, a trained mechanic and a stocked road service truck on call 24 hours, 7days/week, 365 days a year.
- 7. Vendor must have or have access to test facilities with test equipment, including but not limited to: a test pad, digger torque tester, side pull testing apparatus hydraulic test rig. Said facilities are subject to inspection prior to award of bid.
- 8. Vendor must have an established in house process to make fiberglass reinforced plastic repairs and capable of overhaul, repair, and reinforcement of all types of fiberglass components including booms, brackets and guards.
- 9. Vendor must have in house capabilities of providing sheet metal repairs for utility bodies. Including: shearing, forming and welding. Replace doors, wheelhouses and various body panels, which have been damaged or corroded.

- 4. Employees covered by collective bargaining agreements or the Railway Labor Act
- 5. Employees of commercial retail establishments
- 6. Persons not employed in the State of Ohio
- 7. Persons under 18 years of age
- 8. Persons working, on average, less than 30 hours per week

#### Exemptions from Fair Employment Wage Law

The Cleveland City Council, by ordinance, may grant a partial or whole exemption from the requirements of the Fair Employment Wage Law based on hardship. You must demonstrate a specific, particular harm that would be felt uniquely by you if the law were to be applied. Economic harm alone will not suffice to demonstrate hardship unless it is of a type that would not affect any other actual competitor for the contract or subcontract. The following types of specific particular harm may provide grounds for a hardship exemption:

- 1. a loss of profitability that will result in the elimination of jobs
- 2. a loss in profits that will substantially impact your long-term stability

A determination about whether to submit legislation to Council allowing an exemption will be made within ten days of your request. If legislation is submitted to Council to approve an exemption, the Council must then consider and pass that legislation before an exemption will be granted.

#### Health Care Insurance Preference

The bidder may be eligible for a preference if you provide reasonable health care insurance coverage to employees who work over 30 hours a week. However, no preference shall be given if the price bid for the service contract exceeds the lowest price bid by more than five percent (5%). Section 189.031 of the Codified Ordinances of the City of Cleveland defines reasonable health care coverage as a plan that is comparable or superior to the family health care plan offered by the City of Cleveland to its employees.
