Introduction

The City of Cleveland's Department of Community Development ("CD") is issuing this Request for Proposals (hereinafter "RFP") and invites interested consultants to submit their proposal for Financial Empowerment Research:

- Provide professional services including a statistically significant survey of Black residents in the City of Cleveland
- Community Outreach organize and facilitate a series of focus group sessions with a diverse group of city residents
- Drafting and Delivering Report

Definitions

The following definitions are used throughout the RFP:

- Client or City means City of Cleveland, Ohio.
- Vendor or Proposer means a firm, company or organization submitting a proposal in response to this RFP.

General Background and Information

The City of Cleveland has been awarded a grant through The Cities for Financial Empowerment (hereafter "CFE") to help the City create a municipal blueprint to address racial wealth inequity. The final blueprint will include short-term and longer-term policies and programs the City can pursue, with a focus on banking access, financial education, asset ownership, and consumer financial protection. With management oversite from the City, the consultant will complete a robust and resident-centered data collection process which will include conducting focus groups, resident surveys, and engaging with our community partners in the region, in addition to leveraging existing data. The final blueprint will be informed by the needs and solutions identified by residents and the synergies possible through the City's ecosystem of community and funding partners.

Scope of Work

The overall objective of this work is to engage Black and Hispanic residents to understand their experiences. Along with City oversight, prioritize possible policy solutions related to financial empowerment in Cleveland. The City is seeking firms that can support some or all of these tasks.

The City seeks a vendor that can perform data collection and assessment of relevant information to inform and develop a plan for financial empowerment. The vendor should also be capable of making recommendations based on that assessment. Any recommendation must be action oriented and scaled in sufficient capacity to address the scope of the problems identified in the assessment. Intent

It is the intent of the City through this RFP to establish to the greatest possible extent complete clarity regarding the requirements of both parties to the agreement resulting from the RFP.

Before submitting a proposal, the Vendor shall be thoroughly familiar with all conditions referred to in this document and any addenda issued before the proposal submission date. Such addenda shall form a part of the RFP and shall be made a part of the contract. It shall be the Vendor's responsibility to ascertain that the proposal includes all addenda issued prior to the proposal submission date.

The Vendor shall determine by personal examination and by such other means as may be preferred the actual conditions and requirements under which the agreement must be performed.

Basis for Award, Evaluation Criteria and Questions

The City is not obligated to accept any proposal if deemed not in the best interest of the City to do so. The City shall make award to the qualified proposal responder based on fees submitted and response to this RFP.

Failure to include in the proposal all information outlined herein may be cause for rejection of the proposal.

The City reserves the right to accept or reject any and all proposals, in whole or in part, that is deemed to be in the best interest of the City at its sole discretion.

The City reserves the right to waive any informalities or irregularities in proposals.

Confidential Information

Information contained in the Vendor's proposal that is company confidential must be clearly identified in the proposal itself. The City will be free to use all information in the Vendor's proposal for the City's purposes. The Vendor understands that any material supplied to the City may be subject to public disclosure under the Freedom of Information Act.

Confidentiality Statement

Any information, including materials, drawings, designs, documentation, and other property or data, disclosed to the proposal responder shall not be used, reproduced, appropriated, or otherwise disseminated to anyone other than the City.

Tax Exempt Status

The City is exempt from Ohio State sales and use taxes on materials and equipment to be incorporated in the work. Tax Payer Id No. 34-6000646. Said taxes shall not be included in the RFP.

Reserved Rights

The City reserves the right to waive any irregularities; accept the whole, part of, or reject any or all quotations; and to select the firm which, in the sole opinion of the City, best meets the City's needs. The City also reserves the right to negotiate with potential Vendors so that the City's best interests are served.

Advertising

Vendor shall not advertise or publish the fact that the City has placed this order without prior written consent from the City, except as may be necessary to comply with a proper request for information from an authorized representative of a governmental unit or agency.

Trademarks

The City warrants that all trademarks the City requests the Vendor to affix to articles purchased are those owned by the City and it is understood that the Vendor shall not acquire or claim any rights, title, or interest therein, or use any of such trademarks on any articles produced for itself or anyone other than the City.

Right to Request Additional Information

No additional charges, other than those listed on the Price Form, shall be made.

Rights to Pertinent Materials

All responses, inquires, and correspondence relating to this RFP and all reports, charts, displays, schedules, exhibits and other documentation produced by the Vendors that are

submitted as part of the proposal shall become the property of the City upon receipt, a part of a public record upon opening, and will not be returned.

Compliance with the Cleveland Area Business Code

The standard subcontracting goal for professional services contracts is 10% Cleveland Area Small Business ("CSB") subcontractor participation.
